Central to HighRules Ecosystem is the HighRules Token (HRT), a utility token that underpins the entire ecosystem. With a maximum supply of 100

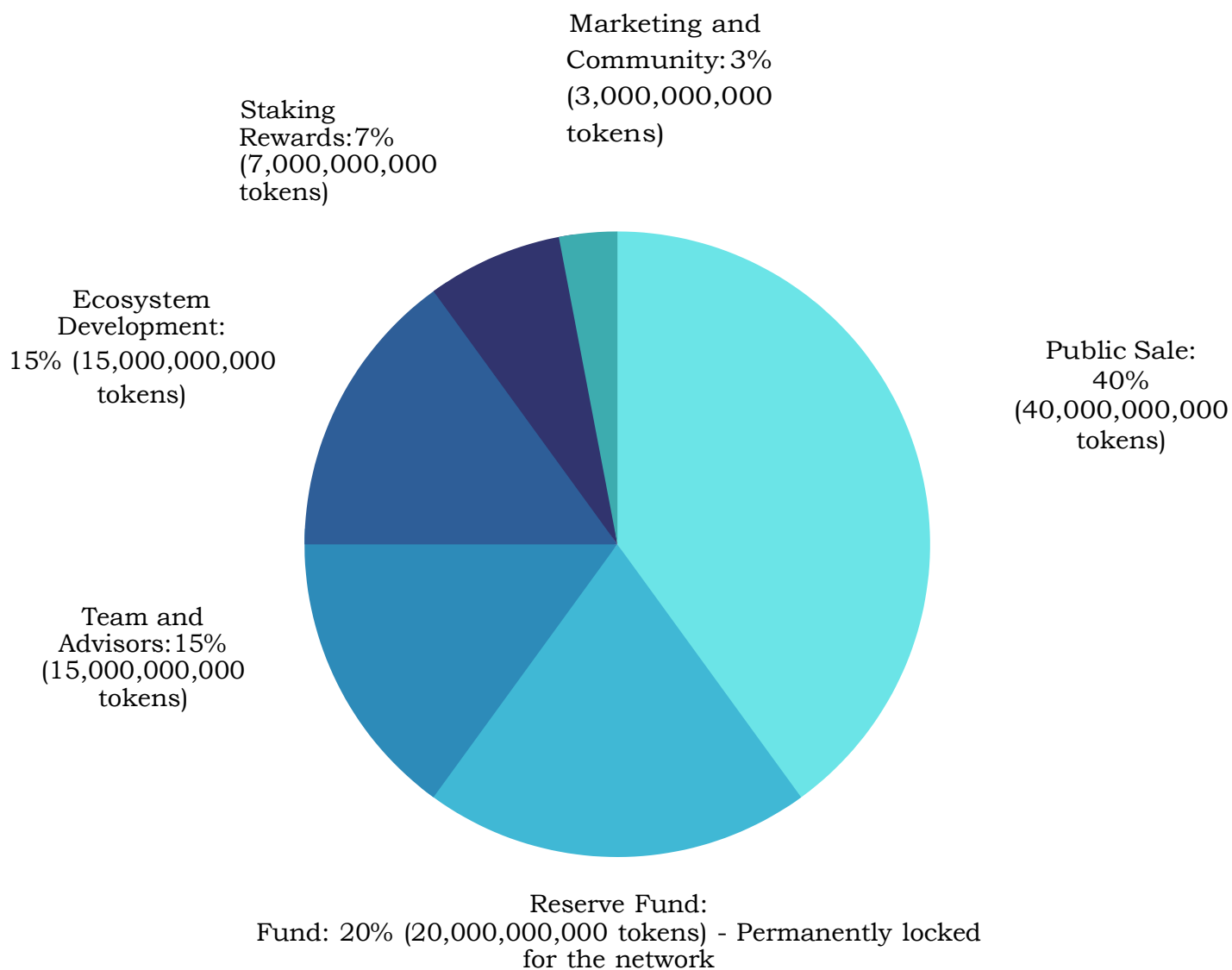

Total Supply: 100,000,000,000 tokens

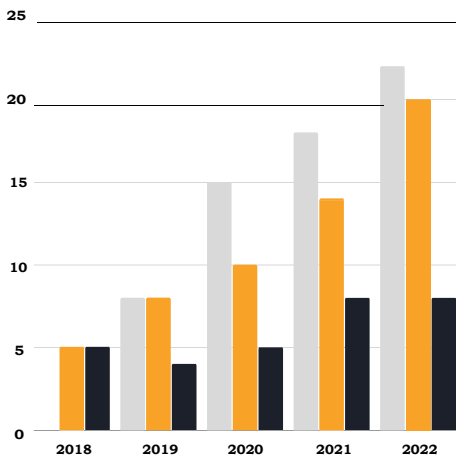
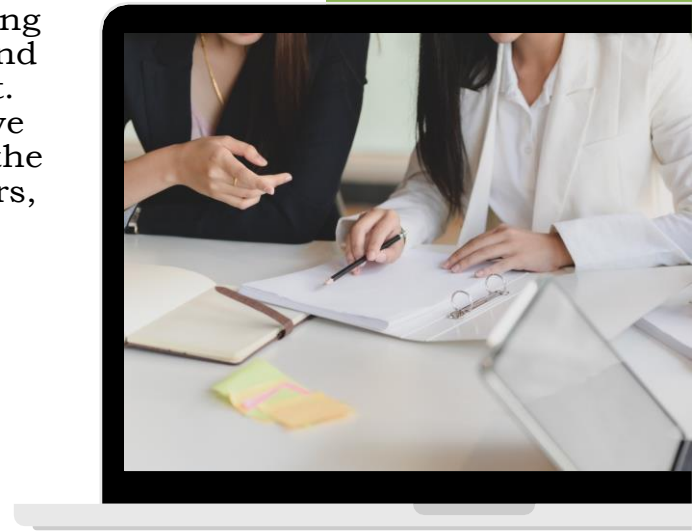
### Token Allocation:

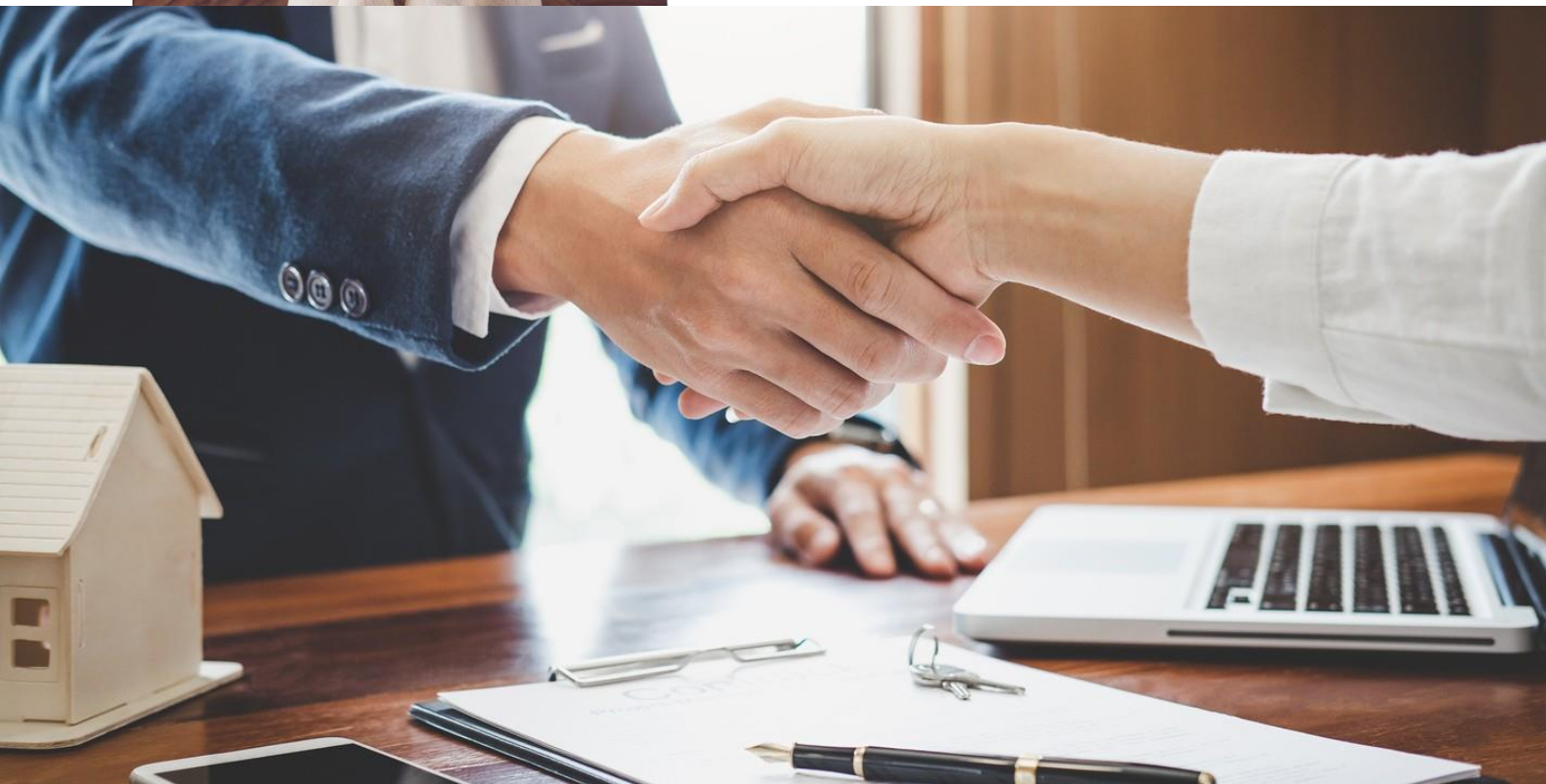

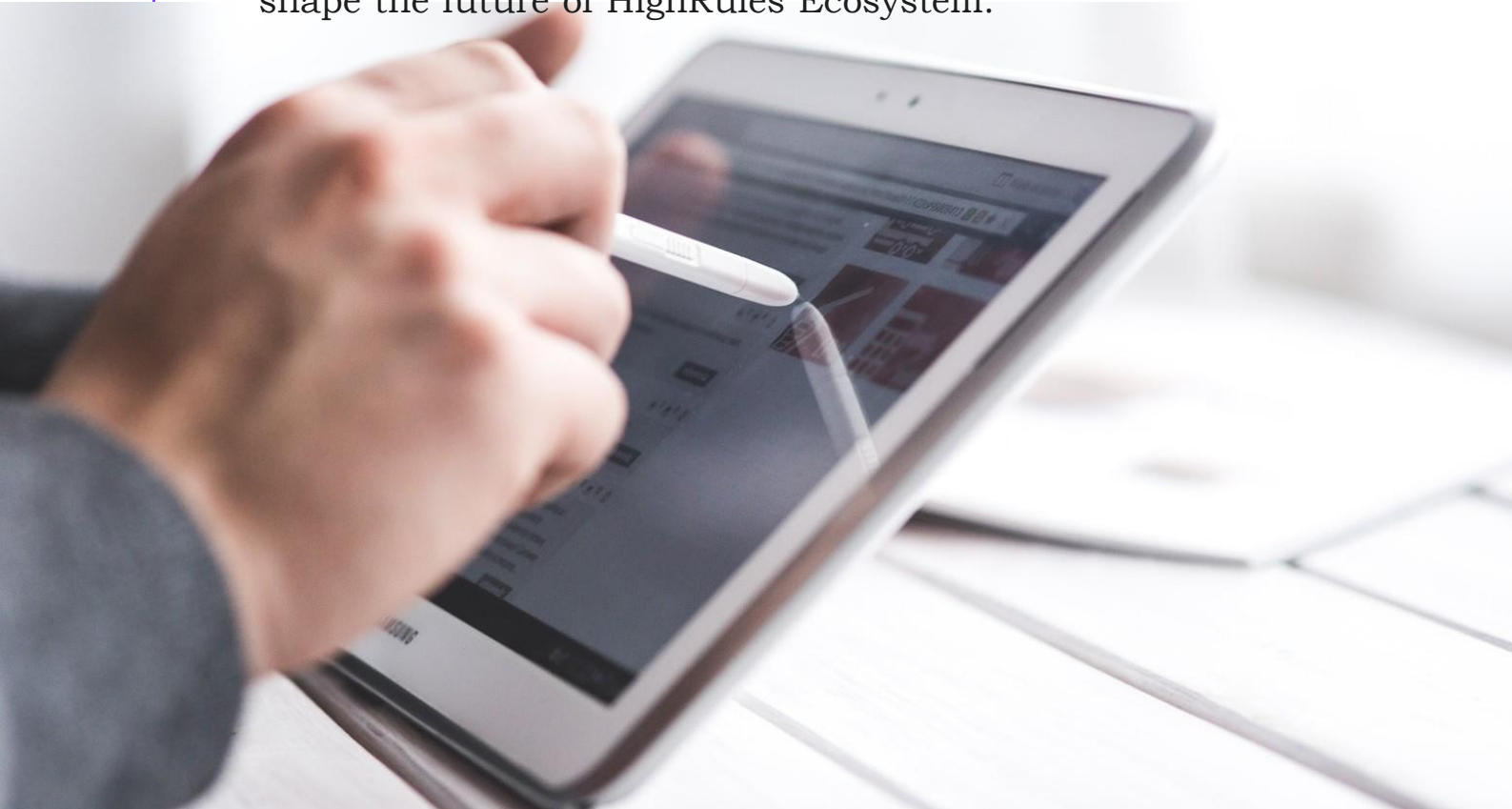

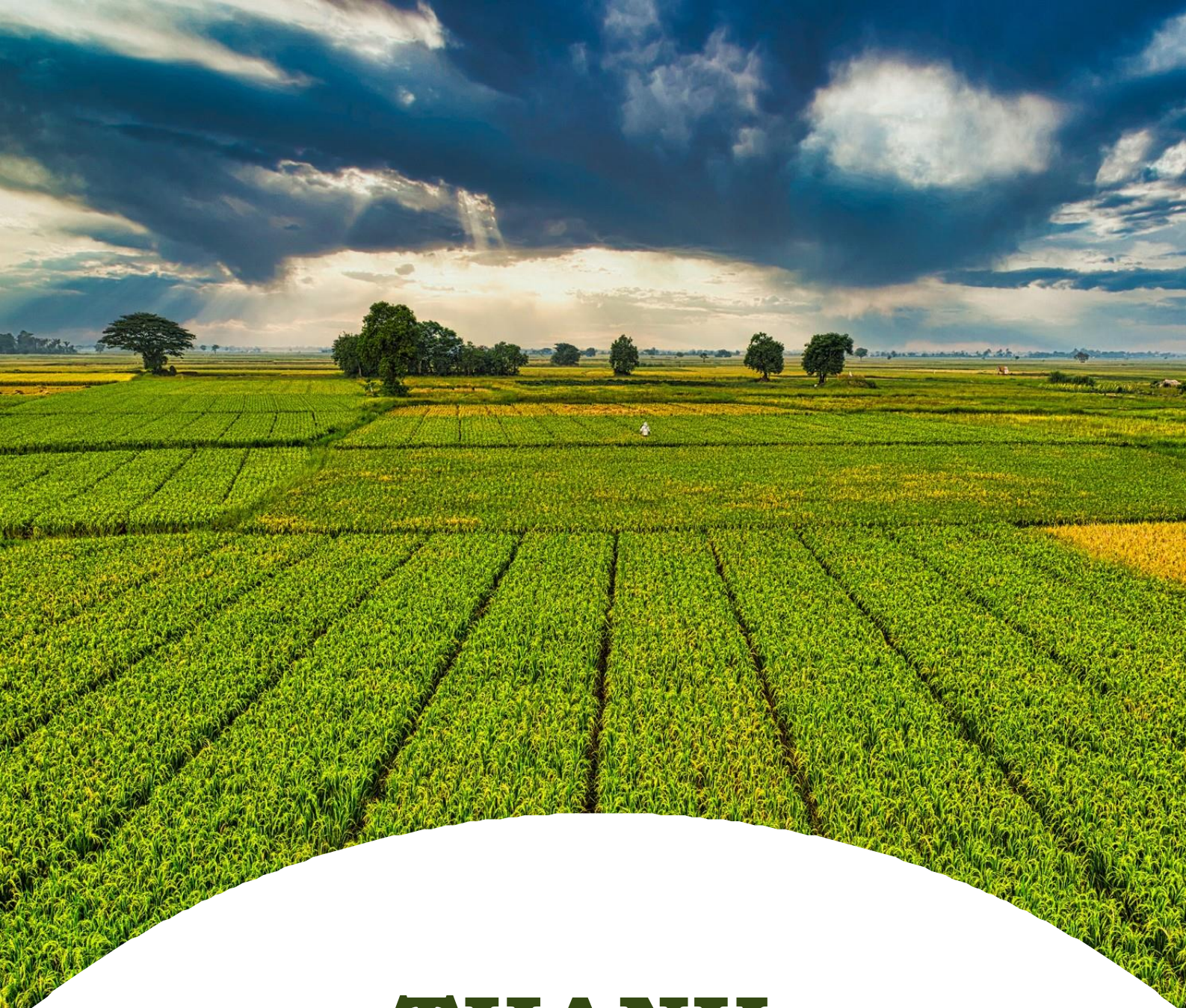
